AN ORDINANCE OF THE CITY OF ELSBERRY, MISSOURI, TO AUTHORIZE THE CITY TO ENTER INTO, AND THE MAYOR TO EXECUTE ON BEHALF OF THE CITY, A STATE PLAN OF OPERATION AGREEMENT WITH THE STATE OF MISSOURI TO OBTAIN SURPLUS U.S. DEPARTMENT OF DEFENSE EQUIPMENT FOR LAW ENFORCEMENT PURPOSES.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELSBERRY, MISSOURI, AS FOLLOWS:

SECTION 1. The City of Elsberry hereby enters into, and the Mayor of the City of Elsberry is authorized to execute on behalf of the City of Elsberry, a State Plan of Operation agreement with the with the State of Missouri to obtain surplus U.S. Department of Defense equipment for law enforcement purposes. The terms of the Agreement are attached to this Ordinance.

The Mayor (and the Chief of Police and the City Clerk at the direction of the Mayor) are also authorized to carry out and perform the terms of this agreement on behalf of the City including executing all necessary authorizations and other documents required to carry out the terms of the agreement.

SECTION 2. Effective Upon Passage

AN ORDINANCE OF THE CITY OF ELSBERRY, MISSOURI, TO PROVIDE PROCEDURES FOR PETITIONING FOR ABATEMENTS AND EXTENSIONS OF PAYMENTS FOR UTILITY USAGE CHARGES BY ADDING NEW SECTIONS 110.101 AND 110.102 TO THE CITY MUNICIPAL CODE.

Whereas, the City needs to obtain complete, accurate, and first hand information when considering petitions for an abatement or extension of payment of utility charges under the City's Municipal Code;

Whereas, the City seeks to ensure that petitions for an abatement or extension of payment of utility charges are fully authorized by the User and are based on representations of fact made by the User;

Whereas, petitions for an abatement of utility charges or extension of payment require orderly and careful consideration by the Board of Aldermen to ensure fairness, both to the petitioning User and to all Users of the sewer and water systems who must bear the costs of those systems; and

Whereas, an orderly and transparent procedure is needed to fully address, fairly consider, and justly resolve all petitions for an abatement or extension of payment for utility charges;

Now Therefore,

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELSBERRY, MISSOURI AS FOLLOWS:

SECTION 1. The Elsberry City Municipal Code is amended by adding new sections 110.101 and 110.112 as follows:

"§110.101. PROCEDURE FOR PETITIONING FOR ABATEMENTS

If any User of the City of Elsberry's water system or sanitary sewer system wishes to petition for an abatement or extension of payment of the User's City of Elsberry utility charges because the User believes that the amount charged on the utility bill is in error by reason of incorrect readings, disruption of service, miscalculation of bill or other similar reason allowed by the City's Municipal Code, the User must submit the petition in compliance with the following procedure.

Abatement or extension petitions must be submitted in writing and signed by the User and the Owner of the Property. Petitions must be submitted on the forms provided by the City Collector.

2. The written abatement or extension petition must be submitted to, and received by, the City Collector within 45 calendar days of the billing date of the bill being disputed or extended. Petitions received more than 45 days after the billing date are untimely submissions and will be returned without action.

- 3. The petition must fully state the reason(s) for the abatement or extension and the amount of abatement or the payment extension plan being requested. The reasons must be permissible grounds for the abatement or extension under the City's Municipal Code.
- 4. The burden of proof for the abatement or extension shall rest upon the petitioner. The abatement or extension petition must include adequate information that will support the petition. Some examples include previous utility bills indicating different meter readings, evidence of mathematical errors in computing charges, evidence of faulty meters, etc., good cause for the extension with adequate assurances of full payment within a reasonable time.
- 5. Abatement or extension petitions will be reviewed by the City Collector and the City Collector will make a written recommendation to the City Board of Aldermen for a resolution of the petition. The City Collector will notify the petitioner in writing of the Collector's recommendation.
- 6. The Petition and the Collector's recommendation will be placed on the next Board of Aldermen agenda after the Collector has issued the Collector's recommendation, provided that there is at least four business days between the recommendation date and the next meeting. If there is less than four business days, the petition and recommendation will be placed on the next following Board of Aldermen Agenda unless the Mayor or an Alderperson representing the Petitioner's Ward requests that the Petition be heard earlier, provided that there is sufficient time to place the Petition on the Agenda pursuant to applicable law. The City Collector shall notify the Petitioner of the date and time of the Board of Alderman meeting at which the petition will be considered.
- 7. The petitioner must be present at the Board of Aldermen meeting in person or by the petitioner's legal counsel. This requirement is to allow the Board to ask the petitioner questions and obtain complete and first hand information needed to address the issues raised by the petition. If the petitioner cannot be at the meeting, the petitioner may request that the petition be heard at a subsequent meeting. Alternatively, the petitioner may file a written statement waiving the petitioner's presence at the meeting and allowing the petition to be resolved on the written petition and its attached exhibits, together with the City Collector's recommendation.
- 8. The Board of Aldermen will review the petition and render a decision by majority vote of a quorum of the Board. The Board of Aldermen may also table the matter to a future meeting should it require additional time or information to make a decision.

§110.102. PAYMENTS PENDING RESOLUTION OF AN ABATEMENT PETITION

To prevent the issuance of late notices and the assessment of interest charges, petitioners must make timely payment of their utility bills. It is not necessary for the abatement petitioner to pay the disputed amount pending the decision of the Board of Aldermen. However, any undisputed amount shall be paid when it is determined to be due. "

SECTION 2. SEVERABILITY.

The provisions of this Ordinance shall be severable. In the event that any provision of this Ordinance is found by a court of competent jurisdiction to be unconstitutional, the remaining provisions of this Ordinance are valid unless the Court finds the valid provisions of this ordinance are so essentially and inseparably connected with, and so dependent upon, the void provision that it cannot be presumed that the Board of Aldermen would have enacted the valid provisions without the void ones or unless the Court finds that the valid provisions, standing alone, are incomplete and incapable of being executed in accordance with the legislative intent.

SECTION 3: EFFECTIVE UPON PASSAGE

This ordinance shall be in full force and effect from and after the date of its passage.

SECTION 4: INCORPORATION INTO THE MUNICIPAL CODE
