AN ORDINANCE TO CORRECT A REFERENCE IN THE EXISTING MUNICIPAL CODE TO THE PROPER CITATION FOR VICIOUS ANIMALS BY AMENDING SECTION 73.150 OF THE ELSBERRY MUNICIPAL CODE.

WHEREAS, in 2014 the Elsberry Municipal Code was amended to split Section 73.020 into two separate sections and expand on the provisions concerning vicious animals;

WHEREAS, the amended section 73.020 did not correctly cite the new section 73.025 concerning vicious animals, but rather contained a typographic error using the reference to the prior location at section 73.020(2);

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELSBERRY, MISSOURI, AS FOLLOWS:

**SECTION 1**: Section 73.020 of the Elsberry Municipal Code is amended to correct the typographic error by deleting the reference of "Section 73.020(2)" in section 73.020, and replacing it with the correct reference to "Section 73.025".

**SECTION 2**: **Severability**. The provisions of this Ordinance shall be severable. In the event that any provision of this Ordinance is found by a court of competent jurisdiction to be unconstitutional, the remaining provisions of this Ordinance are valid unless the Court finds the valid provisions of this ordinance are so essentially and inseparably connected with, and so dependent upon, the void provision that it cannot be presumed that the Board of Aldermen would have enacted the valid provisions without the void ones or unless the Court finds that the valid provisions, standing alone, are incomplete and incapable of being executed in accordance with the legislative intent.

**SECTION 3.** Repeal of Conflicting Ordinances. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

**SECTION 4: Effective Upon Passage**. This ordinance shall be in full force and effect from and after the date of its passage.

**SECTION 5: Incorporation into the Municipal Code**. The City Clerk shall incorporate the terms of this Ordinance into the official City of Elsberry Municipal Code with all due dispatch.
