BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF Elsberry, MISSOURI, AS FOLLOWS:

SECTION 1. The City of Elsberry hereby enters into, and the Mayor of the City of Elsberry is authorized to execute on behalf of the City of Elsberry, a Memorandum of Understanding with the Lincoln County Sheriff's Office for placement of the Sheriff's Office's license plate readers within the City of Elsberry city limits. The terms of the agreement are attached to this Ordinance.

Bill 2024-05-003

AN ORDINANCE AMENDING THE ELSBERRY CITY CODE TO PROVIDE FOR THE APPOINTMENT OF THE CHIEF OF POLICE BY THE MAYOR WITH THE CONSENT AND APPROVAL OF A MAJORITY OF THE BOARD OF ALDERMEN

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELSBERRY, MISSOURI, AS FOLLOWS:

SECTION 1: The Elsberry City Code is amended to delete Section 21.800 and replace it with a

new Section 21.800 as follows:

"§21.800. APPOINTMENT BY THE MAYOR WITH THE APPROVAL OF THE BOARD OF ALDERMEN.

The Mayor, with the consent and approval of the majority of the members of the Board of Aldermen, shall appoint a Chief of Police, who shall hold office until his successor is appointed and qualified the following year. The Mayor shall appoint a Chief of Police at the first meeting of the Board of Aldermen after each annual municipal election of each year. With the consent of the majority of the members of the Board of Aldermen, the Mayor may make the appointment at a later meeting of the Board of Aldermen after the annual municipal election"

SECTION 2. Severability.

The provisions of this Ordinance shall be severable. In the event that any provision of this Ordinance is found by a court of competent jurisdiction to be unconstitutional, the remaining provisions of this Ordinance are valid unless the Court finds the valid provisions of this ordinance are so essentially and inseparably connected with, and so dependent upon, the void provision that it cannot be presumed that the Board of Aldermen would have enacted the valid provisions without the void ones or unless the Court finds that the valid provisions, standing alone, are incomplete and incapable of being executed in accordance with the legislative intent.

SECTION 3: Effective Upon Passage

This ordinance shall be in full force and effect from and after the date of its passage.

SECTION 4: Incorporation into the Municipal CodeThe City Clerk shall incorporate the terms of this Ordinance into the official City of Elsberry Municipal Code with all due dispatch.
