PUBLIC HEARING JUNE 9, 2020 AT 6PM AT ELSBERRY CITY HALL PRIOR TO THE REGULAR SESSION JUNE BOARD MEETING AT 6:30PM

A PUBLIC HEARING was held at Elsberry City Hall at 6PM to hear public comment on, and to consider, a proposed ordinance to amend the existing ordinances concerning zoning for Residential R-1 for Fraternal Use by replacing §41.130 of the Elsberry Municipal Code with a new §41.130.

The application was heard by the Elsberry Planning & Zoning Commission in a public meeting on Monday, May 4, 2020 at 6:00PM at Elsberry City Hall and it was recommended to be approved for this public hearing.

City Attorney Guinness read aloud the Public Hearing agenda based upon the proposed ordinance change including a request to re-build an outbuilding (shed) that was dilapidated behind the residential property at 401 S. 2nd Street in Elsberry, MO that will be voted on later in the meeting. City Attorney Guinness asked if there were representatives present from the Elsberry VFW Post #9064. There were a couple of people present from the Elsberry VFW that explained to the board that the VFW had purchased this residential property along with the shed in the back of the property to hold their fraternal meetings and to use the shed as storage for the VFW. The shed was dilapidated and torn down and they would like to re-build the shed with new plans from Collins Construction on the existing foundation. They are petitioning to have this R-1 fraternal ordinance change and they are re-building the shed as an improvement to the property and to the community. Alderman Hartley thanked the representatives from the Elsberry VFW for investing in our community. City Attorney Guinness asked if there was anyone present from the Planning & Zoning Committee who would like to share their recommendation to the board. Chairman Adam Driesewerd was present and stated that the Planning & Zoning Committee met on Monday May 4, 2020 at 6PM at City Hall and voted to recommend the proposed ordinance change and approved the plans to rebuild the dilapidated shed on its current foundation as storage for the VFW. City Attorney Guinness asked if there was any other comment either in favor of, or in opposition, to the proposed ordinance and there was no public comment.

Mayor Michael Short announced that the Public Hearing was closed at 6:06PM.

Their bid was only for fidelity bond coverage for \$50,000 for the City Clerk, Collector and Treasurer only for \$1,004.

INTRODUCTION AND READING OF BILLS FOR PASSAGE

- Bill 2020-05-001 - AN ORDINANCE RELATING TO, ADDING TO, AND AMENDING THE EXISTING ORDINANCES CONCERNING ZONING FOR RESIDENTIAL R-1 FOR FRATERNAL USE BY REPLACING §41.130 OF THE ELSBERRY MUNICIPAL CODE WITH A NEW §41.130.

Whereas a public hearing was held on Tuesday, June 9, 2020 at 6PM by the Elsberry Board of Aldermen concerning the adoption of this ordinance after due notice published in the Elsberry Democrat.

Whereas the Planning and Zoning Commission recommended that the Board of Aldermen approve this zoning ordinance at their meeting on Monday, May 4, 2020 at 6PM.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELSBERRY, MISSOURI, AS FOLLOWS:

SECTION 1. The Elsberry Municipal Code is amended by replacing §41.130 of the Elsberry Municipal Code with a new §41.130 as follows:

"§41.130 ZONING DISTRICT R, RESIDENTIAL

- 1. There shall be two Residential Subdistricts: R-1 and R-2. The Residential zones shown on the maps are divided into two subdistricts. Areas marked as Residential that lie East of 7th Street and South of Brownsmill Road are zoned as R-1 residential; and all other city Residential lots are zoned R-2. Regulations applicable to residential zones without specifically referring to R-1 or R-2 shall apply to both R-1 and R-2 zoned properties. Regulations applicable to Residential zones without specifically referring to R-1 or R-2 shall apply to both R-1 and R-2 zoned properties.
- 2. Use Regulations. All buildings and land within an R Zoning District shall be limited to the following uses:
 - a. Single-family dwellings.
 - b. Accessory buildings customary, incidental, and subordinate to the use of the main buildings.
 - c. Churches.
 - d. Home occupations.
 - e. Public parks and playgrounds
 - f. Public buildings, facilities, and utilities.
 - g. Fraternal organization meeting places and storage facilities in R-1 zoned property but only if such property adjoins a property currently used by the same fraternal organization on a conforming property. Properties separated by a single street or alley shall be considered to be "adjoining" for purposes of this subsection only.
- 3. Set back Requirements. Main and accessory buildings shall comply with the dimensional requirements of Elsberry Mun. Code §41.200(1). However, the setbacks shall not apply to the reconstruction of an accessory building on a Residential R-1 lot that is demolished, suffers major damage, is or destroyed due to loss of structural integrity, fire, or other casualty provided that the accessory building was built before 1980 on a permanent foundation, the building is reconstructed to its pre-damage dimensions on the pre-damage foundation, the lot is used solely for fraternal purposes, and the owner first obtains permission from the Board of Aldermen to rebuild the building. No such replacement may be made without first obtaining permission from the Board of Aldermen.

- 4. Lot Size Requirements: Minimum width, depth, and minimum lot size shall be provided in accordance with the requirements set forth in Elsberry Mun. Code §41.200(2).
- 5. Special Uses:
 - a. Notwithstanding any provisions of Elsberry Mun. Code §§41.120(3) and 41.200(2) to the contrary, any lot in an "R" Zoning District in existence as of January 1, 1997 that does not meet the lot size requirements of §§41.130(3) and 41.200(2), but has a minimum lot size of 50 feet by 100 feet or 5,000 square feet; may apply for a Special Use Permit to permit the use or construction of a residential building, structure, or improvement on the lot.
 - b. If there is an existing home on any size Residential lot, and it is destroyed or has major damage due to fire or other casualty, it may be rebuilt to its pre-damage dimensions on the pre-damage foundation and up to the set backs existing immediately prior to the damage; provided that the owner first obtains a Special Use Permit to permit the use or construction of a residential building, structure, or improvement on the lot.
- 6. Water Supply and Sewer System. Each lot within an R Zoning District shall be served by a public water supply and a public sewer system.

(Ord. 9-9-1997; 5-1-2005; 8-10-2006; 2019-08-001)

- Bill 2020-06-001 - AN ORDINANCE REGULATING MAINTENANCE OF ALLEYS, STREETS, AND EASEMENTS BY REPLACING SECTION 68.195 OF THE ELSBERRY MUNICIPAL CODE WITH A NEW SECTIONS 68.195 AND 68.196.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELSBERRY, MISSOURI, AS FOLLOWS:

SECTION 1: The Elsberry City Code is amended by replacing §68.195 with new §68.195 and §68.196 as follows:

"§68.195. MAINTENANCE OF ALLEYS.

1. The City shall maintain the surface and subsurface of the alleys owned by the City; or dedicated to, and accepted by, the City.

- 2. The owner of a lot in the City, as well as any other person in possession of said lot, shall be responsible for maintaining any alley or easement area adjoining said lot such that it is free of any of the conditions defined as a nuisance by Sections 68.010 through and including 68.180 of this Chapter; and failing to do so shall itself be deemed a nuisance.
- 3. No person shall cause any damage to the surface or subsurface of any alley owned by the City; or dedicated to, and accepted by, the City; either by neglect, intentional acts, excessive wear, or other improper or inappropriate usage.
- 4. Without the City's express and specific written permission, no person shall remove any surfacing material from any alley owned by the City; or dedicated to, and accepted by, the City.

(Ord. 12-04-2007; 2020-)

§68.196. DEPOSIT, ROLL, FLOW OR WASH OF ANY SOIL, MATERIAL OR LIQUID UPON PUBLIC STREETS, ALLEYS, ROADS OR PUBLIC PROPERTY PROHIBITED.

- 1. No person shall engage in any land disturbing activity or any other action which causes or permits any soil, earth, sand, gravel, rock, stone, concrete, debris, building materials, or other materials, or liquids to be deposited upon or to roll, flow, or wash upon, in, or over any public street, street improvement, road, sewer, storm drain, watercourse, or right-of-way, or any other public property in a manner to damage, obstruct, or to interfere with the normal use of such property, or which creates a hazardous condition detrimental to the health, safety and welfare of the public or vehicular traffic.
- 2. No person shall when hauling soil, earth, sand, gravel, rock, stone, concrete, debris, building materials, or other material, or liquid over any public street, road, alley, or public property allow such materials or liquids to blow or spill over and upon such street, road, alley or public property. The operator of equipment engaged in hauling shall not permit soil, earth, rock or other materials to fall from the vehicle, including wheels of said vehicle, upon such street, road, alley or public property.
- 3. If any soil, earth, sand, gravel, rock, stone, concrete, debris, building materials, or other material, or liquid is caused to be deposited upon or to roll, flow or wash upon any public property in violation of Subsections (1) and (2) above, the person responsible shall be notified and shall cause the same to be removed from such property within four (4) hours, unless a longer period is granted by the Mayor or City Clerk. If a violation described above results from an active residential or nonresidential development, the person responsible shall be deemed either the vehicle operator, developer or prime contractor. In the event of an immediate danger to the public health, safety, or welfare, notice shall be given by the most expeditious means and the material or liquid shall be removed immediately. In the event it is not so removed, the City may cause such removal and the cost of such

removal by the City, or anyone contracted by the City, shall be paid to the City by the person who failed to so remove the material and shall be a debt due the City, and payable within thirty (30) days of said removal.

The cost of such removal, if not paid within thirty (30) days of said removal, shall be a lien upon all property and all rights to property, real or personal, of any person liable to pay the same. The cost of such removal shall be listed on the tax bill and shall be collected in the manner of said taxes. Provided however, that nothing contained in this Section:1shall be interpreted as prohibiting the City from proceeding directly with alternative enforcement procedures set forth in Subsection (1) of this Section.

4. Any person violating the provisions of this Section shall be guilty of an ordinance violation, and upon conviction, shall be subject to a fine and penalty as set forth in the City Code."

There was some discussion on how to maintain the alleys on the surface and subsurface and if the owner would maintain any portion of the alley. Alderman Rockwell stated that there needs to be more discussion on this ordinance as well as discussion to see if there is money in the budget to go towards alley maintenance. The street maintenance needs to be prioritized over the alleys. Mayor Short suggested to table this discussion for an Infrastructure committee meeting with a recommendation to bring back to the full board with detailed wording on the ordinance.

A motion was made by Alderman Rockwell to table this for review at an Infrastructure Committee meeting, seconded by Alderman Taylor.

Bill 2020-06-002 - AN ORDINANCE TO REGULATE THE OPERATION OF BICYCLES AND MOTORIZED BICYCLES BY REPEALING SECTIONS 75.297. 75.298, 76.647, AND 76.650 AND REPLACING THEM WITH NEW SECTIONS 76.300 TO 76.312; AND BY ADDING AN ADDITIONAL DEFINITION TO 76.010

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELSBERRY, MISSOURI, AS FOLLOWS:

SECTION 1: The Elsberry City Code is amended by adding the following definition to §76.010:

§76.010 DEFINITIONS.

"Bicycle" means every vehicle propelled solely by human power upon which any person may ride, having two tandem wheels, or two parallel wheels and one or two forward or rear wheels, all of which are more than fourteen inches in diameter, except scooters and similar devices."

SECTION 2: The Elsberry City Code is amended by repealing 75.297. 75.298, 76.647, and 76.650 and replacing them with new §§76.300 TO 76.312 as follows:

"§76.300. RIGHTS AND DUTIES OF BICYCLE AND MOTORIZED BICYCLE RIDERS.

Every person riding a bicycle or motorized bicycle upon a street or highway shall be granted all of the rights and shall be subject to all of the duties applicable to the driver of a vehicle as provided by chapter 304, except as to special regulations in sections 307.180 to 307.193 and except as to those provisions of chapter 304 which by their nature can have no application.

§76.301. RIDING TO RIGHT, REQUIRED FOR BICYCLES AND MOTORIZED BICYCLES.

Every person operating a bicycle or motorized bicycle at less than the posted speed or slower than the flow of traffic upon a street or highway shall ride as near to the right side of the roadway as safe, exercising due care when passing a standing vehicle or one proceeding in the same direction, except when making a left turn, when avoiding hazardous conditions, when the lane is too narrow to share with another vehicle, or when on a one-way street. Bicyclists may ride abreast when not impeding other vehicles.

§76.302. BICYCLE TO OPERATE ON THE SHOULDER ADJACENT TO ROADWAY WHEN OPERATING LESS THAN POSTED SPEED LIMIT OR FLOW OF TRAFFIC.

- 1. A person operating a bicycle at less than the posted speed or slower than the flow of traffic upon a street or highway may operate as described in §76.301 or may operate on the shoulder adjacent to the roadway.
- 2. A bicycle operated on a roadway, or on the shoulder adjacent to a roadway, shall be operated in the same direction as vehicles are required to be driven upon the roadway.
- 3. For purposes of this section and §76.301, "roadway" is defined as and means that portion of a street or highway ordinarily used for vehicular travel, exclusive of the berm or shoulder.

§76.303. BICYCLE OPERATOR REQUIRED TO GIVE HAND OR MECHANICAL SIGNALS.

The operator of a bicycle shall signal as required in §76.165, except that a signal by the hand and arm need not be given continuously if the hand is needed in the control or operation of or to control or operate the bicycle. An operator of a bicycle intending to turn the bicycle to the right shall signal as indicated in §76.165 or by extending such operator's right arm in a horizontal position so that the same may be seen in front of and in the rear of the bicycle.

§76.304. RIDING BICYCLES, SLEDS, ROLLER SKATES, BY ATTACHING TO ANOTHER VEHICLE, PROHIBITED – PULLING A RIDER BEHIND VEHICLE PROHIBITED.

No person riding upon any bicycle, motorized bicycle, coaster, roller skates, sled or toy vehicle shall attach the same or himself to any vehicle upon a roadway. Neither shall the driver of a vehicle knowingly pull a rider behind a vehicle.

§76.305. RIDING BICYCLE ON SIDEWALKS, LIMITATIONS – MOTORIZED BICYCLES PROHIBITED.

- 1. No person shall ride a bicycle upon a sidewalk within a business district.
- 2. Whenever any person is riding a bicycle upon a sidewalk, such person shall yield the right-of-way to any pedestrian and shall give audible signal before overtaking and passing such pedestrian.
- 3. No person shall ride a motorized bicycle upon a sidewalk.

(Ord. 6-2-2006)

§75.306. Brakes Required on Bicycles and Motorized Bicycles

- A. Every bicycle and motorized bicycle shall be equipped with a brake or brakes which will enable its driver to stop the bicycle or motorized bicycle within twenty-five (25) feet from a speed of ten (10) miles per hour on dry, level, clean pavement.
- B. No parent, custodian, or guardian of a minor shall allow or permit such minor to operate a bicycle without the proper brakes stated in this Section. This is an offense of absolute liability.

(9-01-2006)

§75.307. LIGHTS AND REFLECTORS, WHEN REQUIRED-STANDARDS TO BE MET

- A. Every bicycle and motorized bicycle when in use on a street or highway during the period from one-half (½) hour after sunset to one-half (½) hour before sunrise shall be equipped with the following:
 - 1. A front-facing lamp on the front or carried by the rider which shall emit a white light visible at night under normal atmospheric conditions on a straight, level, unlighted roadway at five hundred (500) feet;

- 2. A rear-facing red reflector, at least two (2) square inches in reflective surface area, or a rear-facing red lamp on the rear which shall be visible at night under normal atmospheric conditions on a straight, level, unlighted roadway when viewed by a vehicle driver under the lower beams of vehicle headlights at six hundred (600) feet;
- 3. Reflective material and/or lights on any part of the bicyclist's pedals, crank arms, shoes or lower leg visible from the front and the rear at night under normal atmospheric conditions on a straight, level, unlighted roadway when viewed by a vehicle driver under the lawful lower beams of vehicle headlights at two hundred (200) feet; and
- 4. Reflective material and/or lights visible on each side of the bicycle or bicyclist and visible at night under normal atmospheric conditions on a straight, level, unlighted roadway when viewed by a vehicle driver under the lawful lower beams of vehicle headlights at three hundred (300) feet. The provisions of this Subdivision shall not apply to motorized bicycles which comply with National Highway Traffic and Safety Administration regulations relating to reflectors on motorized bicycles.
- B. No parent, custodian, or guardian of a minor shall allow or permit such minor to operate a bicycle without the equipment stated in this Section. This is an offense of absolute liability.

(9-01-2006)

§75.310. PENALTY FOR VIOLATION

- A. Any person seventeen (17) years of age or older who violates any provision of §§ 76.300 to 76.303, 76.306, and 76.307 of this Code is guilty of an infraction and, upon conviction thereof, shall be punished by a fine of not less than five dollars (\$5.00) nor more than twenty-five dollars (\$25.00). Such an infraction does not constitute a crime and conviction shall not give rise to any disability or legal disadvantage based on conviction of a criminal offense.
- B. If any person under seventeen (17) years of age violates any provision of §76.300 to 76.303, 76.306 and 76.307, in the presence of a Peace Officer possessing the duty and power of arrest for violation of the general criminal laws of the State or for violation of Ordinances of Counties or municipalities of the State, that officer may impound the bicycle, in-line skates, roller skates, skateboards, motorized bicycle, or scooters or any similar two- or four- wheeled recreational devices being used in violation of §76.295, 76.300 to 76.303, 76.306, and 76.307. The impoundment shall be for a period not to exceed five (5) days. The officer shall issue receipt to the owner or child riding the bicycle, in-line skates, roller skates, skateboards, motorized bicycle, or scooters or any other similar two- or four-wheeled recreational devices.

- C. It shall be unlawful for the parent, guardian or other adult person having the care and custody of a minor under the age of seventeen (17) years to knowingly permit or cause such minor to violate §§76.300 to 76.307.
- D. A "Parent" for purposes of this Chapter means any person who is over the age of eighteen (18) years and is either the natural or adoptive parent (whose parental rights have not been terminated) of a minor or the legal guardian or foster parent of a minor. Except as may be otherwise applicable, if the minor is illegitimate, "parent" shall mean the natural mother. As used herein, "parent" does not include any sibling or other relative, regardless of age, or relation, unless such person is the adoptive parent, foster parent or legal guardian of such minor.

§75.311. LICENSE REQUIRED TO OPERATE MOTORIZED BICYCLE

- 1. No person shall operate a motorized bicycle on any highway or street in this state unless the person has a valid license to operate a motor vehicle.
- 2. No parent, custodian, or guardian of a minor shall allow or permit such minor to operate a motorized bicycle without a license as stated in this Section. This is an offense of absolute liability.

§75.312. EQUIPMENT REQUIRED FOR MOTORIZED BICYCLE.

- 1. No person shall operate a motorized bicycle on any street or highway in this state unless it is equipped in accordance with the minimum requirements for construction and equipment of MOPEDS, Regulation VESC-17, approved July, 1977, as promulgated by the Vehicle Equipment Safety Commission.
- 2. No parent, custodian, or guardian of a minor shall allow or permit such minor to operate a motorized bicycle without a license as stated in this Section. This is an offense of absolute liability.

City Attorney Guinness stated that Chief Davis had recommended this ordinance to provide some regulation on bicycles and bicycle traffic. A bicycle needs to have safety equipment including lights, reflectors, etc. which is in conjunction with state statutes.

A motion was made by Alderman Rockwell to read the ordinance twice by title only, seconded by Alderman Harper.

The ordinance was read twice by title only by Attorney Guinness and a motion was made to adopt the ordinance by Alderman Rockwell, seconded by Alderman Davis.
